



Frequently Asked Questions

What is Single Stream Recycling?

Single stream recycling is a system in which households receive one 95 gallon **recycle cart** in which all approved household recyclables can be placed. These carts provide lots of capacity and an easy closing lid to prevent windblown litter. See the list of approved items in the "Allowable Materials" section that can be placed in the cart.

Do we need to bag the recyclables before placing them in the cart?

No, please **DO NOT BAG** or **TIE** your recyclables before depositing them into the cart. Bagged or tied materials may be left curbside due to the additional expense that debagging requires.

How should I prepare my recyclables for collection?

Flatten all cardboard boxes. Wash and rinse all food and beverage containers. Remove all lids and caps from containers.

Can we place glass, organic material or other material in the carts?

No other materials can be accepted until such time that local recycling processors can efficiently process other recyclable materials. Materials not accepted in our program will not be collected and your cart may not be emptied until the offending materials are removed.

What should we do if we have more recyclables that can fit in the cart?

Extra recyclables should be kept for your next scheduled pickup. Should you regularly have more material than your cart's capacity, please contact Loraas Disposal to arrange for an additional cart.

My normal regular pick up falls on a statutory holiday, do I still put out my cart?

Loraas Disposal collects on all statutory holidays except New Year's Day, Good Friday and Christmas Day. Please check your collection calendar for your scheduled pick up days including holidays.

Dear Members of the Red Coat Waste Resource Authority;

As you are aware, Loraas Disposal has been providing collection services to Members of the Authority since January 1st, 2012. Collection has included residential curbside waste collection as well as transfer station waste and recycling collection.

We are excited to announce the addition of Residential Single Stream Curbside Recycling collection for your community. All homes that presently receive waste collection services using a cart will receive a new blue recycling cart. **Your new blue cart will be delivered in late August, 2014 and collected biweekly beginning in September.**

Single stream recycling allows residents to recycle a wide range of materials in the same container without sorting. Please see the pamphlet included with this letter to understand what can and cannot be placed in your recycling cart in addition to other information regarding this new service.

Because of the convenience of residential waste and recycling services and the ability to divert a major portion of materials from the garbage cart, effective September 1, 2014, waste collection services will change to biweekly.

Your collection day will stay the same; however, garbage and recycling services will alternate week by week. Please see the calendar included with this letter to understand your schedule.

Also included in this package is a letter that shows any collection day changes for statutory holidays. A digital copy of your community's 2014 collection calendar can be downloaded via our website.

In addition to the implementation of biweekly service, the Red Coat Waste Resource Authority will also eliminate waste and recycle transfer stations to encourage the further diversion of waste from the landfill. This change will also take place September 1st, 2014. Loraas Disposal is able to offer waste and recycling services to businesses and other individuals affected by the elimination of these transfer stations.
